General Eligibility and Application Information

- The program offers rebates for a portion of the cost of purchasing and installing high energy efficiency measures.
- To qualify, you must be an Ameren Missouri Natural Gas customer.
- Installations of measures completed as part of a new construction project are not eligible for rebates through this program.
- Submit your rebate application online at https://amgas.programprocessing.com or visit AmerenMissouri.com/naturalgas to print and complete the appropriate September 1, 2020-August 31, 2021 rebate form.
- Additional requirements apply to audit improvement measures:
 - Rebates are available for the purchase and installation of specific gas-efficient equipment and building shell measures. These rebates are available for measures installed upon the recommendation of a Qualified Auditor performing a comprehensive energy audit at the site. Measures installed are eligible for only one rebate through the Ameren Missouri Natural Gas efficiency programs.
 - A Qualified Auditor is defined as a contractor trained in natural gas equipment utilization systems and commercial and/or residential structures as an integrated whole building system through a nationally recognized training, certification and accreditation organization such as the Building Performance Institute (BPI) and Residential Energy Services Network (RESNET®).
 - If applying for a ceiling or wall insulation rebate, you cannot also apply for an audit improvement rebate for insulation. You may only apply
- Depending upon the measure installed, you will need to submit some or all of the following documentation along with your online or paper rebate application:
 - Your most recent Ameren Missouri Natural Gas bill
 - All applicable invoices and/or receipts
 - Proof of cost of associated labor
 - Signature verification from your installer/contractor
- Rebate checks will be mailed approximately 6-8 weeks following receipt of the complete rebate packet.
